### **Location**

The premises are located in Berkhamsted, a popular commuter town to the northwest of London, with a population of approximately 19,000. The property is close to the edge of the town centre and is within a short walk of all main amenities including shops, parking and the railway station.

### **Description**

The building comprises a detached Grade II Listed Religious building all on one level constructed in 1818 with a large front and rear garden. The property is set back and is of solid brick walls under a pitched slate roof with attractive rounded arch sash windows at front and rear. There is a path externally providing disability access to a side door.

Internally there are three steps up inside the main entrance to a small lobby with unisex and disabled persons WC. This then leads to a large main hall with high ceilings of approx 3.9m (12ft 11). There is a second, middle room and a kitchen to the right hand end, with rear door leading out to a garden at the back.

### **Planning**

The property is believed to have been in continuous use as a religious meeting house since it was built and we are of the opinion that it should therefore benefit from an established use as a Class F1 Place of Religious Worship. Other Commercial or Community uses may be suitable subject to planning, but tenants are advised to obtain their own advice on this.















